Online bids must be valid for a period of 90 days counting from the day of bid opening and must be accompanied by bid security, amounting to NRs. 3,65,000.0 which shall be valid for minimums 30 days beyond the bid validity period. The scanned copy of bid security should be uploaded in the e-GP system during bid submission.
