A complete set of Bidding Documents may be purchased from the office *Supreme Court of Nepal (Store Section)* by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of *NRs. 1,000/-* till *2076/11/27 (15th days from date of publication)* during office hours.
4. Sealed bids must be submitted to the office *Supreme Court of Nepal, Ramshahpath, Kathmandu* by hand before *12:00 PM 2076/11/28 (16th day of date of publication)*. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend on *13:00 PM, 2076/11/28 (16th day from date of publication)* at the office of *Supreme Court of Nepal, Ramshahpath, Kathmandu*. Bids must be valid for a period of *45 days* after bid opening and must be accompanied by a bid security amounting to a minimum of *NRs. 50,000/-* which shall be valid for *30 days* beyond the validity period of the bid. If bidder wishes to submit the Cash Security, the cash should be deposited in *Nepal Rastra Bank, Baluwatar (Deposit Account No. 1201200001002524) of Ko.Le.Ni.Ka., Babarmahal (Office code No.: 204003501)* and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
